
\$0 for City-related façade improvement permits for a vacant or occupied commercial space.

TO QUALIFY, A PROPERTY MUST:

- Be located in Downtown, Civic Neighborhood or Central Rockwood. (See map below)
- Update existing construction, not undertake brand-new construction.
- Not exceed 5,000 square feet for each leasable tenant space; total building must not exceed 30,000 square feet.
- Sign an agreement with the City covering terms, obligations, timelines, etc.



Start or expand your business in our Central Rockwood, Civic Neighborhood or Downtown incentive zones. Or put a better façade forward with our remodel incentive for property owners in these same areas.



GARAGE TO STOREFRONT IS BROUGHT TO YOU BY:





GARAGE TO STOREFRONT PROGRAM DOES NOT COVER:

- Corporate or franchise stores with more than three existing locations.
- Government offices or agencies. Businesses or properties that:
- 1. Exclude minors at all hours. 2. Create new construction. 3. Have a drive-thru.
- 4. Must obtain a Type II or Type III Community Service Permit. (example: childcare facilities)



NEW OR EXPANDING BUSINESS INCENTIVE

Apply today to take advantage of vacant space within specific commercial areas and City-related fees and charges for new or expanding business will be waived, including:



- Commercial tenant improvement permit fee (building, sign and other development fees)
- System development charges (SDCs)
- Business license fees

TO QUALIFY, A BUSINESS MUST:

- Operate in the designated areas of Downtown, the Civic Neighborhood, or Central Rockwood
- Occupy no more than 5,000 square feet of existing, vacant commercial space
- **Be** a new or existing business expanding by at least 10% of floor space
- **Sign** an agreement with the City covering terms, obligations, timelines, etc.
