Will look for two people that can take on roles to be on a Communication team to assist NGNA's online presence. Board will speak on the communication preliminary plans at the next meeting.

6:18 PM Discussed a motion to gather more information about communication efforts. Physical media (i.e., making flyers to handout and post at public places.) Also seeking to update previous NGNA yard signs to announce meetings. Invite new members. Divide NG neighborhood into zones and reach out to knock on doors to promote attendance at upcoming member meetings as able. Board would like to print flyers and leave them at peoples doors as well. Jesse would like to print flyers. He will get a

draft printed to present to members. Gelinda likes the idea and volunteers to speak at our next meeting about communications.

6:21 PM Gelinda was asked if she understands her role as Treasurer. Her response was yes. She is familiar with the role as she served as NGNA President before deactivation. She will reach out to get more information as needed.

6:23 PM Discussed motion to ask the city to pay for our two postcards per year. They said many other Gresham Associations combine meetings on one postcard so that City will cover expense. Motion to have NGNA's postcards sent in 2026 as follows: Meetings for February and May announced on card sent for February meeting and meetings for August and November announced on card sent for August. 6:25 PM Jesse was asked if he understood his role as Land Use Officer. His response was that he is gathering information to get familiar. This obviously will take time. He briefly met the prior NGNA Land Use Chair incumbent at NGNA reactivation meeting, and will reach out to her and other mentors as needed.

6.32 PM Discussed motion to plan a Spring Clean Up between February in May. The date and locations of Spring Clean up will be discussed <u>at our next meeting</u>. Annette volunteered to ask the city for a speaker to be present at a future meeting to talk about safety and illegal dumping along areas of concern. Board Officers agreed this includes 192nd Avenue & Wilkes Road, Kirk Park, and parts of The Gresham/Fairview Trail are areas wished to be cleaned up. Contact the City with questions regarding jurisdiction maintenance responsibility, cleaning supplies, hazardous waste disposals, etc. NGNA residents and business owners will have a chance to discuss concerns and plan for ideas of resolution <u>at the next meeting</u>.
