This notice of dissolution of a reimbursement district is executed on the date shown below by the City of Gresham, Oregon, a municipal corporation within the State of Oregon.

City of Gresham Resolution No. 3458, a resolution distributing the final costs of the Brookside North (Kelley Creek Trunk) Sewer Reimbursement District was passed by the Gresham City Council on July 6, 2021, and recorded July 22, 2021, as Document No. 2021-112537, official records of Multnomah County, Oregon. It was recorded as a notice to property owners subject to the reimbursement district. On September 16, 2025, the Gresham City Council adopted Resolution 3667, dissolving the Brookside North (Kelley Creek Trunk) Sewer Reimbursement District.
