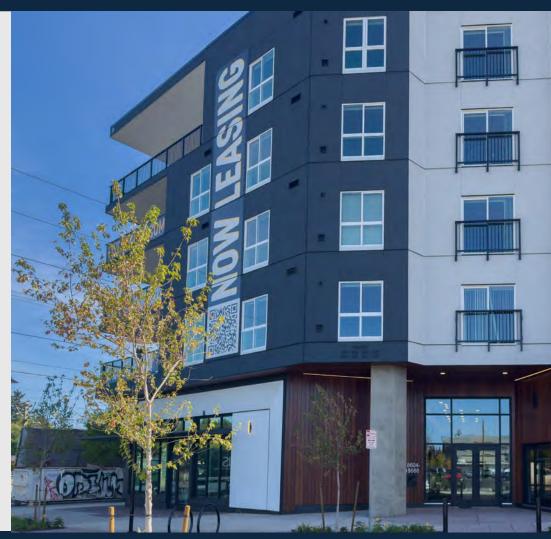

Fire Station 74

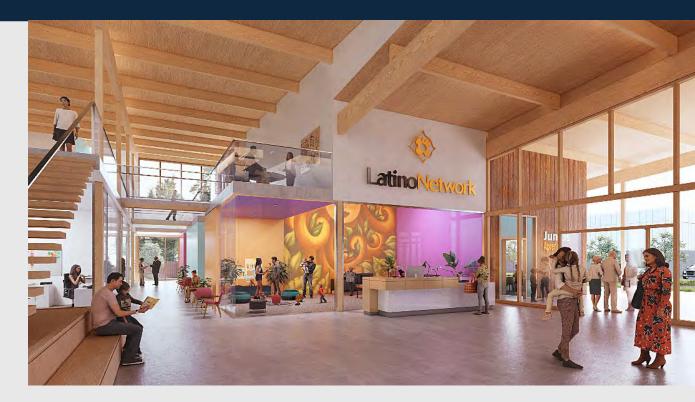
 Completed schematic design, cost estimates, and master planning for new fire station at 1520 NE 192nd Avenue

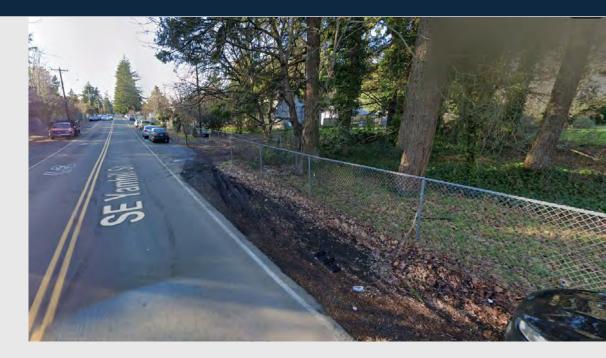

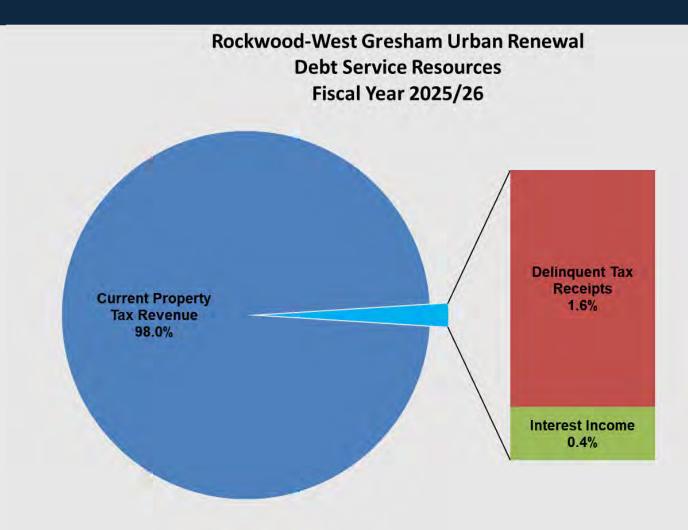

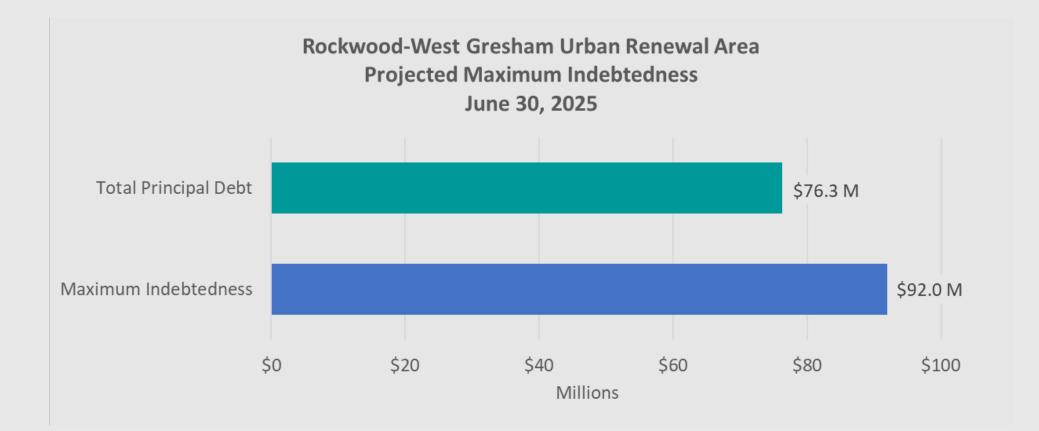


Tax Revenues

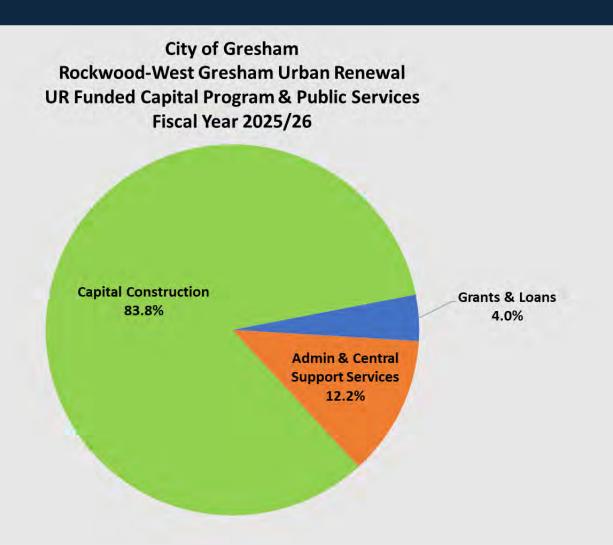
